Re: Lifting of Voluntary Suspension and Restoration of Time

Dear Mr. Igbanugo:

The purpose of this letter is to inform you that the U.S. Small Business Administration (SBA), Office of Business Development (BD) is lifting the voluntary suspension IGBANUGO PARTNERS INT'L LAW FIRM PLLC requested on 4/8/2020. This action is being taken in accordance with 13 C.F.R. § 124.305(h)(1)(iii), which provides that a Participant whose principal place of business is located in a federally declared disaster area may elect to voluntarily suspend its participation in the 8(a) BD program for a period of up to one year from the date of the disaster declaration. IGBANUGO PARTNERS INT'L LAW FIRM PLLC requested a voluntary suspension in connection with the March 13, 2020, nationwide coronavirus emergency disaster declaration. Consequently, SBA must lift IGBANUGO PARTNERS INT'L LAW FIRM PLLC's voluntary suspension no later than March 12, 2021.

Our records indicate that the effective date of IGBANUGO PARTNERS INT'L LAW FIRM PLLC's voluntary suspension was 4/8/2020. IGBANUGO PARTNERS INT'L LAW FIRM PLLC was initially scheduled to complete its 8(a) BD program term on 11/21/2020. SBA has restored 228 days to IGBANUGO PARTNERS INT'L LAW FIRM PLLC's 8(a) BD program participation term. The new program end date for IGBANUGO PARTNERS INT'L LAW FIRM PLLC is 10/26/2022. Please note that this new program end date also reflects any period of program extension authorized under section 330 of the Consolidated Appropriations Act, 2021, Public Law 116-260, Div. N, title III, sec. 330 (Dec. 27, 2020).


